

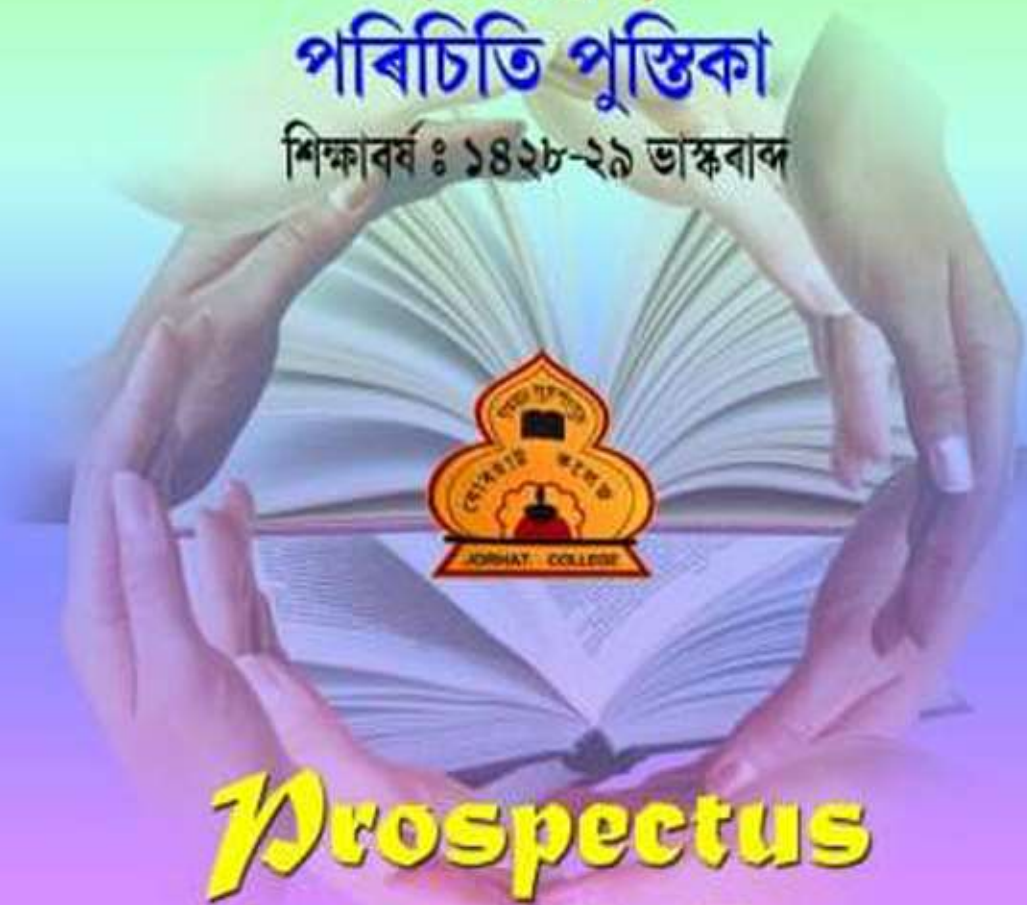

1.1 Programmes Offered: The College imparts :

- a) Eight Semester CBCS course in Arts under Dibrugarh University.
- b) Three years degree course in Arts in Distance mode under Dibrugarh University.
- c) Two year Higher Secondary Course under Assam Higher Secondary Education Council.(A/S)
- d) Three year degree course/ M.A. in Arts in Distance Mode-under KKHSOU.
- e) Certificate course in different languages
- f) Two year M.A. Course under Dibrugarh University under Distance Mode.
- g) Two year M.A. Course under Dibrugarh University under Open Mode., (A/F)
- h) Nearly 30 Self Financing Courses/ Add-on Courses

1.2 Courses of Study & Examination Pattern :

Higher Secondary (2-year course) in Arts: (Seat Limit - 150 only.)

1.3 Medium of Instruction:

The medium of instruction is Assamese but a student, if he / she desires, may also receive necessary instruction in English and may answer in English in any examination.

The medium of instruction for major programme would be both English and Assamese

H.S. Arts :

- a) **Compulsory Subjects :** (i) English (ii) M.I.L. (Assamese) or Alternative English
- b) **Elective Subjects (any three/four): (Arts)**
 (i) Economics (ii) Education (iii) History (iv) Logic and Philosophy (v) Political Science
 (vi) Sociology (vii) Mathematics (viii) Geography (ix) Statistics (x) Computer Science

Rs. 1000/- will be collected at the time of admission for Self Financing Course (both for 1st & 2nd year)

N.B. Admission to H.S. classes/ Senior Secondary Classes would however depend upon Govt. decision in this regard.

N.B.: Students have also the option to appear in one additional subject (4th) of 100 marks. In that case the subject in which the examinee secures the lowest marks would be treated as the 4th at the time of declaring the results.

1.4 Programme Registration:

- a) Students will have to fill the registration form at the time of admission clearly mentioning their course/subject combinations.
- b) **In no circumstances, change of subject combination and switching from one to another shall be allowed.**

1.5: Attendance**A) Higher Secondary Students :**

★ 75% attendance in class is compulsory for all students, falling short of which will make a student non-collegiate. Students having attendance below 50% will be treated as discollegiate. The non-collegiate students will be fined at the time of filling in the Examination form as per University and Council rules, while the discollegiates will not be allowed to go for the Examination.

B) Degree Student: Under C.B.C.S. System:

★ 100% attendance in class is compulsory. Students having less than 80% attendance will not be allowed to appear in the End Semester (Final) Examination.

1.6: Examination and Evaluation of Eight Semester Degree Programme under New Education Policy:

THE FOUR YEAR UNDERGRADUATE PROGRAMMES (FYUGP) IN CHOICE BASED CREDIT SYSTEM (CBCS)

JORHAT COLLEGE (AMALGAMATED)

As Per Dibrugarh University Regulations¹ for the Four Year Undergraduate Programmes (FYUGP) in Choice Based Credit System (CBCS), 2023

(The Regulations shall be applicable to the students enrolled in the aforementioned academic programmes conducted by Colleges affiliated by Dibrugarh University from the academic session 2023-24.)

Undergraduate Programmes: Undergraduate programmes will include the following:

- (i) **UG Certificate programme:** UG Certificate Programme leads to a UG certificate

after completing 1 year (2 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG certificate (in the Field of Study/Discipline) after securing the requisite 44 Credits on completion of Semester II if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the stipulated maximum period of seven years.

- (ii) **UG Diploma Programme:** UG Diploma Programme leads to a UG diploma after 2 years (4 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG Diploma (in the Field of Study/Discipline) after securing the requisite 88 Credits on completion of Semester IV if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 4th semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the maximum period of seven years.
- (iii) **Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major:** Students who wish to undergo a 3-year (6 semester) UG programme shall be awarded UG degree in the Major discipline after successful completion of three years, securing a minimum of 132 credits. Provision of double Major shall be implemented in due course of time.
- (iv) **Four Year UG Programme with honours (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major:** Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the Major discipline after successful completion of four years, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.
- (v) **Four Year UG Programme with honours with Research (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major:** Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours and research degree in the Major discipline after successful completion of four years with a rigorous research project, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.

Credit: A 'credit' is a unit by which the coursework is measured. It determines the number of hours of instruction required per week over the duration of a semester (minimum 15 weeks). A course may have only a lecture component or a lecture and tutorial component or a lecture and practicum component or a lecture, tutorial and practicum component, or only practicum component. Credit shall be defined as

Academic Bank of Credits (ABC): 'Academic Bank of Credits (ABC)' is an academic service mechanism as a digital/virtual/online entity established and managed by MOE/UGC to facilitate students to become its academic account holders and paving the way of seamless student mobility, between or within degree-granting Higher Education Institutions (HEIs) through a formal system of credit recognition, credit accumulation, credit transfers and credit redemption to promote distributed and flexible teaching learning.

Academic Flexibility: 'Academic Flexibility' is the provision for innovative and interchangeable curricular structures to enable creative combinations of Courses/Programmes in disciplines of study leading to Certificate/Diploma/Degree of study offering multiple entry and multiple exit

facilities removing the rigid curricular boundaries and creating new possibilities of life-long learning.

Credit accumulation: 'Credit Accumulation' means the facility created by ABC in the Academic Bank Account opened by the students across the country in order to transfer and consolidate the 'credits' earned by them by undergoing 'courses' in any of the eligible HEIs.

Credit recognition: 'Credit Recognition' means the credits earned through eligible/partnering HEIs and transferred directly to the ABC by the concerned HEIs.

Credit redemption: 'Credit redemption' means the process of commuting the accrued 'credits' in the Academic Bank Account of the students maintained in ABC for the purpose of fulfilling the 'credits requirements' for the award of Certificates/Diplomas/Degrees etc. by the degree awarding HEIs.

Credit transfer: 'Credit transfer' means the mechanism by which the eligible HEIs registered with ABC are able to receive or provide prescribed 'credits' to individual registered ABC account in adherence to the UGC credit norms for the 'course/s' registered by the desirous students in any HEIs within India.

Semester Duration:

- i) *Odd Semesters: July–December (including end-semester examinations and semester breaks)*
- ii) *Even Semester: January-June (including end-semester examinations and semester breaks)*

Any change in the Academic Calendar/Schedule may be made by the University whenever necessary.

Extent of Application:

The Regulations shall be applicable to the students enrolled for the Courses of Study leading to the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research)

Academic Schedule: The Academic Schedule of the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) Programmes shall be administered as per the Academic Calendar of the University published for every academic session.

Minimum eligibility criteria for admission in Four Year Undergraduate

programmes: Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education

and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.

Minimum eligibility criteria for multiple entry points of the UG programmes

- a. **1st year:** Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.
- b. **2nd year:** A certificate obtained after successful completion of 1 year (2 semesters) of the undergraduate programme. These students are to take admission in the 2nd year within a period of three years from obtaining the UG certificate from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
- c. **3rd year:** A diploma obtained after successful completion of 2 years (4 semesters) of the undergraduate programme. These students are to take admission in the 3rd year UG programme within a period of three years from obtaining the UG diploma from Dibrugarh University or any other University/institution recognized by Dibrugarh University.
- d. **4th Year (Honours):** A Bachelor's degree after successful completion of three years (6 semesters) of the Undergraduate programme obtained from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.
- e. **4th Year (Honours with Research):** A three year Bachelor Degree with a minimum of 7.5 CGPA. The minimum entry requirement for 4th year (Honours/Research) UG programme within a period of three years from obtaining 3 year Bachelor Degree from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.

Attendance

The Course Teacher shall be responsible for maintaining a record of attendance of students who have enrolled for the course.

All Course Teachers of college/institutions shall intimate the Principal/ Director of a college/

Institute through the Head of the Department concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.

In case of University Departments/Centre for Studies all course teachers shall intimate the Head of the Department/Chairperson of the Centre for Studies concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.

A student who has less than 80% attendance in average shall not be permitted to sit for the End-semester examination. However, that it shall be open to the University to grant exemption to a student who has attended a minimum of 70% classes but failed to obtain the prescribed 80% attendance for valid reasons, on recommendation of the Head/Chairperson/ Principals of the Department/Centre/College on payment of a prescribed fee(s).

The Head of the Departments/Chairperson of the Centre for Studies/Principals of the Colleges shall announce the names of all students who shall not be eligible to take the End- semester examinations in the various Programmes and send a copy of the same to the Controller of Examinations. Such candidates shall have to repeat the concerned Course(s) when it is offered next.

A student declared as dis-collegiate shall not be allowed to proceed to the next higher Semester. He/she shall need to pursue the Semester afresh in which he/she was declared as dis-collegiate along with the next fresh batch.

4. INFRASTRUCTURE AND LEARNING RESOURCES

- 4.1 **Hostel Facility :** The college has limited hostel facility for Girls (both for HS & Degree level) within the college Campus. At present the number of seats is 45. Application form for hostel admission may be collected from college Office at the time of admission. Two seats will be reserved for each Department in Degree level. The Hostel Management Committee will finalize the list of candidates. The hostel Dues for six months must be paid by the boarders at the time of admission. The boarders will have to abide by the rules and regulations of the College Hostel as mentioned in the Admission form.
- 4.2 **Canteen Facility :** The College canteen provides the students with light refreshment at a reasonably cheap rate in a hygienic condition and arranges for pure drinking water in the college campus.
- 4.3 **Medical Facility :** The college has a Medical Cell which organizes a Health Day annually for the health check-up of the newly admitted students. The findings of the check-up are recorded in the students' database as well as in the Health Card issued to the students. Besides, the cell provides the students, teachers and employees of the College with the facility of free medical check-up twice a month.
- 4.4 **Library Facility :** The College has a rich computerised library with Reading Room facility. Most of the daily news papers, journals and magazines besides computers and internet facility are available in the reading room. The students must abide by the rules of the library. There is a provision for an orientation programme in the beginning of the session by the librarian.
- 4.5 **Language Research Centre & Laboratory :** The college is going to introduce a language learning course in different regional languages such as Mising, Karbi, Bodo, Tiwa, Deori etc. apart from some foreign languages- French, Spanish and German to start with in order to introduce the learners to the basics of grammar, sound pattern, word meaning, word formation etc. of the target

language so that they can comprehend the language in an accurate manner. The learners will be facilitated with study guide, Self learning materials and audio visual components for enhancing their learning capacity. It is expected that the learners would be able to speak and use the target language in their day to day communication. A language laboratory with 10 computers have already been setup.

- 4.6 Book Bank :** The College has the facility of a Book Bank for the benefit of the poor students. It is a provision for lending text books only to economically backward students on merit basis. To avail the benefit of the same the students will have to apply in a given form to be obtained from the Librarian along with a certificate of income from the local S.D.C. or Moujadar. The beneficiaries will be selected purely on merit basis from the applicants. The textbooks will be issued for one academic year and the same will have to be returned by the beneficiaries before the issuing of the admittance card for the final examination.
- 4.6 Departmental Library :** The members of the teaching staff have at their own initiative launched a modest effort towards establishing eight departmental libraries for the benefit of the major students of each department.
- 4.7 Games and Sports :** The College offers as far as possible adequate facilities of games and sports for both boys and girls. The facility of a multigym, a synthetic Basketball court and synthetic Badminton Court is available in the Campus.

5. STUDENT SUPPORT :

- 5.1 Career Counselling and Entrepreneurship Development Cell :** The College has an active "Career Counselling and Entrepreneurship Development Cell" which organizes workshops, seminars, lecture programmes etc. from time to time with a view to guiding the students in choosing their career and developing an entrepreneurial bent of mind. The Cell has also been conducting several skill-based programmes like. Beautician, Fabric and Glitter Painting, Interior Decoration etc. from time to time for the benefit of the students. The Cell conducts usually the following career programmes (a) workshop on Time management and priority factor, (b) Communication and Body Language, (c) Preparation for Interview, (d) Interview facing skills, (e) Career talks etc. Apart from these the Cell has been conducting a Personality Development class for the Degree students in the daily time table.
- 5.2 Grievance Redressal Cell :** The College has a Grievance Redressal Cell to meet the grievances of the students, teachers and the employees. A Complain and Suggestion Box has been placed in front of the room where the grievants may place their grievances and/or suggestions in black and white.
- 5.3 Gender Sensitization & Sexual Harassment Prevention Cell :** The College has a Cell for sensitizing its students and staff on gender issues and thereby preventing sexual harassment.
- 5.4 Scholarships and Awards :** The following scholarships and awards are available to the eligible students of both Higher Secondary and Degree courses.
- a) National Merit Scholarship.

- b) OBC, MOBC, SC, ST Scholarships.
- c) From Students' Aid Fund, Free Studentship is granted to deserving poor students. Applications for Free Studentship must be submitted by the students when called for.

5.5 AWARDS :

- a. **Tarun Mohan Goswami Memorial Awards** : Three cash awards are given in the name of Tarun Mohan Goswami, a former Vice-Principal of the college who besides being a dedicated teacher in Economics, was also a good singer. These awards are managed from the annually accumulated interest of the Tarun Mohan Goswami Memorial Trust Fund formed with donation of the family and well wishers of late T.M. Goswami. The college authority has also contributed a sizable amount of late for the fund. Following are the awards.
 - ★ **Students securing highest marks in Economics among the successful candidates from this college in the Higher Secondary and B.A. 6th Semester (Major) Examinations will be entitled to the Torun Mohan Goswami Memorial Award. In case of H.S. Examination, the awardee must secure at least 75% marks in Economics and get admitted in CBCS class of this college. In case of B.A. 6th Semester Examination, the awardee must secure at least 60% marks in Economics Major.**
 - ★ **The best singer in the Annual Music competition held during the College Week will also be entitled to the Tarun Mohan Goswami Memorial Award.**
- b. **Bhoben Kumar Bora Memorial Award** : It is a cash award donated by Dr. Nilima Bora, Associate Professor, Department of Economics, to commemorate her younger brother, Bhoben Kumar Bora, a young intellectual who died in an accident. The award would be given to the best literary competitor in the Annual College Week.
- c. **Best Student Award** : An Award comprising a trophy and a certificate is given annually to a student selected as the best student through continuous observation of his/her conduct, attendance, performance in the class as well as extra-curricular activities by a committee of teachers entrusted by the principal for the purpose. **Sishuram Gogoi and Labonya Gogoi Memorial Best Student of the Year Award : By Dr. Inee Gogoi, Dept. of Entomology, AAU, Jorhat and Dr. Diganta Kr. Phukan, Dept. of Sociology, Jorhat College.**
- d. **The Most Regular Student Award** : A student from each class is selected for the "Most Regular Student Award" for the highest percentage of attendance. The eligibility criterion for this award is minimum 90%. This award comprises a certificate and a trophy.
- e. **Dr. Pravash Kr. Bora Memorial Award of Rs. 5000/- for best student of Sociology (final)**
- f. **Ishan Baruah Memorial Award for economically poor but academically excelled student.**
- g. **A new award for the student securing highest mark in B.A. Final exam from Jorhat College, in memory of Dipali Neog (to be offered by Ms. Jutimali Saikia, H.O.D. Education)**

N.B.:The scholarship holders are to observe strict discipline and be regular in classes and examinations, failing which their scholarship may be cancelled. Payment of scholarships is made through Bank Accounts to be opened by the scholarship holders with State Bank of India (SBI), Jorhat Branch.

- 5.6 **Dr. Ambedkar Study Centre** : Recently a study centre named after Dr. Ambedkar, the father of Indian constitution has been set up. It would focus on casteism and untouchability and would organize national seminars and also to publish a journal.

6. CO-CURRICULAR AMENITIES:

- 6.1 **National Cadet Corps (NCC)** : The NCC wing of the College was opened with 52 male cadets from August, 2006 under 9 Assam Bn. NCC, Jorhat. The cadets have successfully participated in several local as well as national level camps. Cadets even took part in the rally held at New Delhi on the occasion of Republic Day. Several cadets have successfully completed the 'C' Certificate examination. The CTO of the wing is Mr. R. J. Hazarika, Assistant Professor, Department of Assamese.

The girls' wing of NCC was also opened with 25 cadets from August, 2008 under 64 Assam Girls' Bn. NCC, Jorhat. The number of cadets was doubled the next year. The cadets have been participating in several local and national level camps and extension activities ever since. MS. Purnima Padi, Assistant Professor, Department of Education is the CTO of this wing.

- 6.2 **The National Service Scheme (NSS)** : The College provides opportunity for the students to develop their personality and a sense of social responsibility through community services under the National Service Scheme (NSS). Dr. Ranjit Bhattacharya, Assistant Professor, Department of Philosophy is the programme officer of NSS.
- 6.3 **Scouts** : There is facility for Scouts training for boys by a qualified teacher. This training is most essential because it helps the students to develop honesty, righteousness, social obligation and patriotism.
- 6.4 **Students' Union** : The students have their Union under the name and style of Jorhat College Students' Union which is the general body of the students of the College. The union functions in accordance with its constitution. The Union Fund is derived from the contribution of the students. Office bearers of the Union Executive are elected annually. For contesting any portfolio in the election, students must have minimum 75% attendance in class as per the Supreme Court's directions.
- 6.5 **Students' Magazine** : The Students' Union annually publishes a magazine which gives the students the opportunity to develop their literary talent.
- 6.6 **Wall Magazine** : Besides the annual magazine, the students' union also publishes a quarterly Wall-Magazine. Various departments also publish their Journals/ Wall Magazines etc., on their own.
- 6.7 **Memorial Lectures & Debates** :
- i) **S. N. Rajkumar Inter College Debating Competition** : The College hosts an inter-College Debating Competition in the memory of Late S.N. Rajkumar, a former Principal of the college.
 - ii) **Arun Chandra Puzari memorial lecture** : The college organises a bi-annual lecture

programme under the initiative Let Puzari's son, Prof. Dr. Soumitra Puzari. Let A.C. Puzari was a founder teacher in the Deptt. of History, Jorhat College.

- iii) **Jehiruddin Ahmed Memorial Lecture** : The college organises a lecture programme in the memory of Jehirudding Ahmed, a renowned educationist and founder President of Jorhat College Governing Body.

The classes are held from 9:00 am to 3:45 pm. The College office remains open from 10:00 am to 4:00 pm in all week days excepting holidays and half holidays.

All students are required to attend College in Uniform as given below :

Boys : White Shirt and Grey Pant (Formal Shirt & Pant)

Girls : White Mekhela-Chadar with Grey border and Grey blouse or Grey Kurta with White Salwar and White Dupatta. (Patiwala or Semi-Patiwala) Winter Wear (For both Boys and Girls) Black Sweater / Blazer.

- ★ The College will supply the Pant piece for boys and the Kurta piece for girls @ Rs.300/- and Rs.300/- respectively which the students must purchase at the time of admission.

N.B.: All students are expected to dress properly (Formal Dress)

10. IDENTITY CARD :

All bonafied students of the College will be given Identity Cards which must be worn all the time. For Identity Card a student must furnish a stamp-sized photograph, information about his / her blood group, personal identity mark, mother / father / guardian's name, telephone number etc. In case of loss of Identity Card a student must obtain a fresh card after paying a fine of Rs. 100/- (A fine of Rs. 30.00 + Rs.70.00 Cost)

11. GENERAL RULES FOR MAINTENANCE OF DISCIPLINE AMONG STUDENTS:

1. Students disturbing congenial and decent Physical and General environment of the college would be considered as violators of discipline. They should maintain both physical and mentally dignified conduct both inside and outside the College. Anyone found creating or conducting indecent environment may be punished ranging from imposition of fine upto expulsion, the degree and quantum of which will depend upon the nature of indecent behavior and the view of the disciplinary committee.
2. Students are expected to be respectful towards principal, vice principal, teachers, librarian and the other office staff and dignitaries. Disobedience may invite punishment, interalis, fine, suspension. Public condemnation and washing, finally expulsion or other

- measures that the discipline committee might deem fit.
3. A) The students opting to bring mobile/tablet inside the college campus have to take permission and obtain a sticker available on payment of Rs.100. The sticker has to be affixed on the mobile/tablet and the use of mobile/tablet would be restricted to Boys' and Girls' Common Room and the Canteen. Mobiles/tablets without the sticker will not be allowed within the campus of the college.
b) The violation of the above rule may invite fine and also confiscation of the mobile/tablet in extreme circumstances. The fine is to be paid to the teacher or staff delegated to collect the fine.
c) The first time violator would be fined Rs.100/- only. Which would be increased to rupees five hundred for subsequent violation and the mobile phone may be confiscated.
 4. In case of clash among two student/two groups/ one student and a group, the degree and quantum of the action taken will be determined by the disciplinary committee.
 5. Boys and girls are not allowed to mix properly. The degree of indecency will be determined by the disciplinary committee.
 6. Hair make up should be normal except in case of religious formalities.
 7. Dresses like sporting, jeans, leggings, Balloon pants etc are not allowed to put on.
 8. Students are strictly not allowed to use indecent word or having indecent conversation inside the college.
 9. Late arrival in the classroom is not allowed.
 10. No students would be allowed to carry objects like cigarettes, tobacco, intoxicants, drugs, pornographic materials into the college campus.
 11. students would not be allowed to enter the college campus in inebriated condition.
 12. The rules imposed by the college authority mentioning & Ragging is to be followed.
 13. Eve teasing, stalking and similar misconducts are strictly prohibited. Any case of gender related harassment/exploration/ humiliation will be dealt with most firmly. Those will be referred to GSCASH and Disciplinary committee may decide to punish the guilty by warning, fining, publicly condemning, suspending and even expelling.
 14. The fine imposed upon the guilty may vary from Rs.100/- to Rs.3000/- depending upon the gravity of the case. The fine collected will be spent to enrich the college library.
 15. The discipline committee is empowered to deal with other cases of violation of discipline which may come up from time to time.

I have read the above rules and agree to abide by each of them failing which I would accept the punishments meted out me.

Steps taken by UGC to prevent ragging in Educational Institutions.

1. In January, 2000, UGC circulated the guidelines prepared by UGC Expert Committee on curbing the menace of ragging to all Universities for taking necessary action.
2. In July, 2007 UGC again wrote to all Universities sending the Dr. Raghavan Committee Report (Committee constituted by M/HRD on the orders of Supreme Court) on measures of prevention of ragging in educational institutes for strict compliance.
The reports are available on UGC Website www.ugc.ac.in
3. As per the Raghavan Committee report the Universities are to set up :
 - i) Anti ragging Squads
 - ii) Anti ragging committees
 - iii) Mention in the prospectus of possible action against ragging.
 - iv) Publicize the name/telephone no. and address of the authorities to be contacted.
 - v) Counselling of seniors and freshers.
 - vi) Conduct orientation courses for freshers.
 - vii) Report action taken by the anti ragging squads and anti ragging committee to UGC.
 - viii) No. of cases of ragging to be mentioned in the prospectus along with the punishment given to the guilty.
 - ix) Erect suitable hoardings/bill boards banners in prominent places within the campus.
4. The UGC has requested for Information/feedback from the Universities on the steps taken for curbing ragging in the prescribed proforma.
5. The Universities have been instructed to mention in every prospectus if any incident of ragging comes to the notice of the authority the concerned student shall be given liberty to explain and if his explanation is not found satisfactory the authority would expel him from the institutions.
6. The Commission has created a cell for dealing with ragging in educational institution.

Subject: Supreme Court of India Orders – Curbing Ragging in Educational Institutions – Inclusion of No. of Ragging Incidents in Prospectus/Brochures.

Sir/Madam,

In continuation of this Office letter of even no. dated 03.03.2008, on the above subject, I am directed to say that the Hon'ble Supreme Court of India in SLP (C) No.24295/2004 in the matter of University Kerala v/s Council of Principals, Colleges of Kerala and others, the Apex Court has expressed displeasure on the incidents of ragging in the educational institutions despite directions to prevent such incidents in educational institutions.

(2) In the last hearing held on 10th December, 2007 in the case related to prevention of ragging in higher educational institutions the Supreme Court has expressed concern over the incidence of ragging occurring in higher educational institutions and the need to eliminating it altogether. Accordingly, as directed by the Court, instructions have been issued by the regulatory bodies UGC / AICTE / MCI etc., for inclusion of the clause in the prospectus regarding punishment of students with expulsion etc, if found guilty of ragging. The Committee set up by the Supreme Court to Monitor the measures being taken to prevent ragging has now **decided that along with the number of cases of ragging in the previous academic session, the punishments awarded to those found guilty should also be mentioned in the brochures/prospectus of the higher educational institution.**

(3) It may also be stated that the Report of the Raghavan Committee constituted as per directions of the Supreme Court of India to give suggestions on means of prevention of ragging in educational institutions, is already posted on UGC website www.ugc.ac.in. The prescribed format for compliance report already circulated vide UGC office letter of even number dated 20th November, 2007.

(4) The Second meeting of Raghavan Committee to Monitor Measures to Prevent Ragging in Higher Educational Institutions appointed by the Supreme Court of India constituted by Ministry of Human Resource Development headed by Dr. K. Raghavan, Ex-Director of CBI was held on 02.04.2008 in New Delhi and the Committee has inter-alia given the following directions to all regulatory bodies :

That the Universities/Colleges should mention in their prospectus/brochure that the total number of "Ragging Incidents" taken place in their Institution in each year for information to the public.

(5) The Ministry of Human Resource Development, Government of India, Department of Higher Education, vide their letter No. 9-18/2008 (U-5) dated 29th April, 2008 has requested to take up suitable campaigns against ragging, inter-alia suggesting the following :

The Institutions may erect suitable hoardings / bill boards / banners in prominent places within the campus exhort the students to prevent or not to indulge in ragging and also indicating therein the names of the officials and their telephone number to be contacted in case of ragging.

The Educational Institutions may also undertake any other form of campaigns as it may consider appropriate for prevention of ragging.

(6) It is requested that necessary action may be taken. This may also be brought to the notice of the colleges affiliated to your university.

(7) Action taken report in this regard may please be sent to this office early.

PREVENTION OF RAGGING IN EDUCATIONAL INSTITUTIONS

ABSOLUTE NO TO RAGGING

- According to the directions of the Supreme Court of India in University of Kerala vs. Council of Principals of Colleges in Kerala, ragging within or outside any educational institutions is prohibited.
- "Ragging" means doing an act which cause or is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage of modesty or injury to a student.
- The University Grants Commission (UGC), New Delhi has also taken stern view of the problem of ragging and has issued the necessary guidelines to curb the same.

The following recommendations need immediate implementation according to the Supreme Court / Raghavan Committee recommendations / UGC instructions :

- The punishment to be meted out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents;
- Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied with the institutional arrangement for action, a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities;
- Courts should make an effort to ensure that cases involving ragging are taken up on priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness;
- The Court directed the exploration of possibility of introducing in the educational curriculum, a subject relating to ragging;
- In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he has indulged in ragging, admission may be refused or he shall be expelled from the educational institution;



- The Central Government and the State Government shall launch a programme giving wide publicity to the menace of ragging and the consequences which follow in case any student is detected to have been involved in ragging;
- Role of the concerned institution shall also be open to scrutiny for the purpose of finding out whether they have taken effective steps for preventing ragging and in case of their failure, action can be taken against them too;
- Anti-ragging Committees and squads shall be forthwith formed by the institutions to see that the Committee's recommendations are observed without exception and if it is noticed that there is any deviation, the same shall be forthwith brought to the notice of this Court; and
- The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the Anti-Ragging Committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.

Acts Amounting to Ragging could be :

- Teasing, Embarrassing and Humiliating;
- Assaulting or Using Criminal Force or Criminal Intimidation;
- Wrongfully Restraining or Confining or Causing Hurt;
- Causing Grievous Hurt, Kidnapping or Rape or Committing Unnatural Offence; and
- Causing Death or Abetting Suicide.

Let us together curb this menace.

1. Please stay away from ragging.
2. Ragging is a criminal offence as per law passed by a number of state governments.
3. Rustication from the college.
4. Embossment on Mark Sheets, Degree Certificate etc. stating that he/she indulged in Ragging.
5. Penalty and imprisonment of one year.
6. Fine.
