2/Department of Sociology, Cinamara College and Department of Sociology, Jorhat College, (Amalgamated) shall jointly organize students workshop and Seminar.


3/Both the Department of two institution shall collaborate to organize extension activities in neighbouring villages of the both the Institution.

Nanda Nath Saikia College is a leading provincialized college affiliated to Dibrugarh University, Assam. The college was established on 22nd July, 1959. The College is located in Titabar town, about 21 km from the district headquarter of Jorhat and recognized as one of the premier institutions of the region in the field of Higher Education. The Department of Assamese is the premier department and was established in 22nd July, 1959. The Department works for academic excellence and community upliftment from its inception.

Jorhat College (Amalgamated) is an Arts College of co-education. The name by itself commemorates the history of amalgamation of two different colleges, viz., Jorhat College and New Jorhat College. 
It is expected to benefit largely the students and faculty members of both the Departments through this MOU.


TERMS:

7. The two departments will try to involve each other jointly in the field based studies


Through this MOU, the two departments will try to make their goal success.

Purpose and objective of the MoU

The Department of Assamese, Nanda Nath Saikia College and Department of Assamese, Jorhat College, Jorhat, Assam both undertake to promote and develop academic cooperation as follows:

- Exchange of academic and administrative staff and students;
- Extension of students' learning opportunities;
- The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Placement for students;
- Exchange of cultural activities;
- Cooperation in research and the presentation of its results;
- Exchange of academic materials, publications and other scientific information; and
- Other educational and academic exchanges.

TERM AND TERMINATION:

1. This Agreement shall commence from the Effective Date and shall continue to be in force for a period of five (5) years thereafter ("Term"), unless renewed further or earlier terminated. The Agreement may be renewed or extended by mutual agreement (in writing) between the Parties at any time during the Term.
2. Notwithstanding anything herein contained, either Party may forthwith terminate this Agreement immediately under any one or more of the following conditions:
 - a. In the event of a remediable breach of this Agreement by the other Party that remains uncured for a period of seven (7) days after written notice of breach to the defaulting Party by the aggrieved Party;
 - b. It can be extended if the review committee recommends it
 - c. This MOU will be automatically invalid after five years unless renewed.

Entire Agreement:

The Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior written agreements, understandings and negotiations, both written and oral, between the Parties with respect to the subject matter of the Agreement.

No Third-Party Beneficiaries:

Neither the Agreement nor any provision hereof is intended to confer upon any Person other than the Parties to the Agreement any rights or remedies hereunder.

Severability:

The invalidity or unenforceability of any provisions of the Agreement in any jurisdiction shall not affect the validity, legality or enforceability of the remainder of the Agreement in such jurisdiction or the validity, legality or enforceability of the Agreement, including any such provision, in any other jurisdiction, it being intended that all rights obligations of the Parties hereunder shall be enforceable to the fullest extent permitted by law.

Legal Fees:

Each Party is to pay its own legal costs and disbursements incidental to the preparation, completion and signing of the Agreement.

Assignment:





Dispute Resolution:






